- This agreement shall be governed by the laws of the Province of British Columbia and is complete and represents the entire agreement between the undersigned parties.
- Both parties signing below agree to defend, indemnify and hold harmless to each other and their respective officers, agents, and other employees from all claims, suits, actions, liabilities, costs, and expenses (including attorney's fees) resulting from injuries (including death), to all persons, including, but not limited to, guests, patrons, invitees, volunteers, contractors, or suppliers of materials, caused by the negligence or wilful misconduct of either parties, their officers, agents, or other employees, or volunteers. Both parties acknowledge that their obligations under this paragraph shall survive the termination of this agreement.
- Both parties signing below expressly understand and agree that the Nanaimo Dragon Boat Festival Society, or any of their officers, agents, volunteers, assistants, contractors, or employees, shall not be held responsible or made the subject of any claim seeking to assess damage or liability for or arising from loss of any other sort to sponsor a result of a change in scale or scope, a move to a different date, postponement, or cancellation of the event entirely.
